

GREENWOOD TOWNSHIP ANNUAL MEETING MINUTES
MARCH 11, 2025 – 8:15 PM

1. Clerk Debby Spicer calls meeting to order.

2. Nominations for Moderator. Election of Moderator.

Mike Ralston is nominated by Mike Indihar/Jet Galonski. **Vote carried**
Mike Ralston begins as moderator and leads in the Pledge of Allegiance.

3. **MOTION** by Mike Indihar /Steve Roskoski to accept Agenda as presented. **Vote carried**

4. **MOTION** by John Bassing/Mike Indihar to dispense with reading of minutes from 3/12/24 Annual Meeting and approve them. **Vote carried**

5. Board of Audit Report presented by Clerk Debby Spicer. The disbursements and receipts did not match, unrecorded check stubs were missing. When Deputy Treasurer was asked to retrieve stubs and other records, she had told the Board she didn't have keys to the Treasurers desk and did not have password to Treasurers computer. With lack of records and cooperation from Deputy Treasurer, the Board of Supervisors determined to discontinue the Board of Audit until Clerk/Treasure books can be reconciled and records can be presented, or an audit can be completed.

MOTION BY Mike Indihar/Mary Worringer to delay Board of Audit, as Supervisor Roskoski had recommended, until books are reconciled. **Vote carried**

6. Road Report presented by Road Supervisor, Pauk Skubic.

Our one and only road, Birch Point Extension, aka County Rd 4136. Had potholes filled and cracks sealed. It turned out real nice. A contractor has been hired to do brushing this coming summer.

7. Fire Department Report presented by Fire Department Liaison Craig Gilbert. Two snowmobile EMS assist calls, and a total of 15 EMS calls in the last month. We have a new EMR member who has completed her training and is also interested in joining the Fire Department in the future. The Breathable Air Compressor has been repaired and is now working as designed. Quotes were presented for additional much needed maintenance and Wildland FF PPE (gear).

9. Citizen's Comments.

Paul Thompson, President of Greenwood Township Recreation Committee, presented a thorough update on the numerous accomplishments and fundraising success, future plans, and maintenance needed.

Debby Spicer brought up a request made at last year's annual meeting for benches needed along the walking/bike trail. I would like that issue considered for the upcoming season.

James (Jet) Galonski stated that in the past, Greenwood hired a maintenance director that took care of most of the needed Town Hall and property maintenance and would like to see that position restored. The Fire Department has been doing some but doesn't have the time needed. Some maintenance has been contracted out, but some is being neglected.

Geri Ankrum reminded us that Greenwood Township built the tennis courts, not the Rec Board and the fact the Rec Board is willing to help maintain it is commendable.

Joann Bassing complimented on the care of the flowers around the Gazebo.

10. 2026 Budget Presentation/Levy Approval (Chair Roskoski).

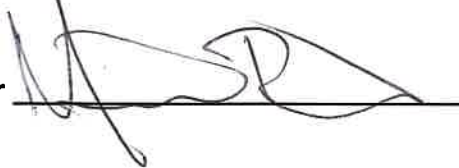
